This document records new features and bug fixes implemented between August 27, 2025 to October 27, 2025.

Features & Improvements:

Enhanced User Experience & Interface

- Branding Changes: The visual theme across the entire application, including the Data Services user interface, has been updated with new color schemes for improved readability and a consistent look.
- **General Enhancements:**
 - The response message displayed during the user onboarding process, specifically when checking if a user already exists, has been updated for clarity.
 - Users will now not be allowed to configure services and will be prompted to create a project before configuration, ensuring proper organization and resource allocation.
 - Enhanced controls for comment privacy have been introduced, allowing users to manage the visibility of their comments more effectively. Specifically, comments made on Marketplace items can now be designated as private, visible only to the commenter and the publisher of the item, ensuring confidential communication when needed.

My Tenant

- **Audit Logs Tab:**
 - Implemented centralized logging for all platform activities, visible to tenant admin and super admins only.
 - It provides a unified view of activities across the entire platform, including Marketplace, Generative AI, and Project-related actions. This centralized logging significantly improves visibility, simplifies monitoring, and streamlines troubleshooting processes for admins.
- The "Pending Tasks" section now includes a dropdown filter, allowing tenant admins to easily sort and view tasks by categories such as "Operations" and "Security." This helps in quickly prioritizing and managing different types of pending actions.
- License-based controls are now available across the platform, allowing for granular management and enforcement of feature access and functionalities based on user and tenant licenses.
- Granular Cost Filtering: The "Spend & Budgets" section now includes enhanced filtering capabilities, allowing administrators to refine cost reports and monitoring data by specific folders, projects, and services. This provides a more granular view of expenditures and aids in precise budget management.

Project Management

- Full project restore and backup options are now available for all services, ensuring comprehensive data protection and recovery capabilities for your work.
- Users can now create backups, schedule their frequency, and define retention policies. Informative help-texts and icons are provided to guide users through these configurations, ensuring they understand how these features work.
- The ability to back up individual services within your projects has been enhanced, offering granular control over data protection for specific components.



- Tenant admins can now set up both soft and hard budget limits for projects within the "My Projects" section. This allows for better financial control and planning for individual projects.
- **Service Catalogue:**
 - Access Type Key Addition: A new Access Type key has been introduced for both MLflow and Cloud Run services. This allows for better definition and management of how these services can be accessed.
 - CMEK Key Field Addition: The CMEK Key field has been added to the Data Service MONAI. This enhancement provides support for Customer-Managed Encryption Keys, improving data security and compliance.
 - Specialized Service Account: This new service allows for the instant creation of specialized service accounts with pre-approved roles from your catalog. It ensures secure, consistent, and fully automated access management for your applications and services, offering fast and secure provisioning, standardized permissions, and scalable machine learning workflows.
 - Croissant Library Integration: The Croissant library has been integrated for use with Compute Engine and Vertex AI services, and is now available for consumption via the Marketplace, enhancing data handling capabilities.
 - New services are now available in the Service Catalog for direct consumption from the Marketplace.
 - Cloud Composer: A fully managed workflow orchestration service that helps you create, schedule, and monitor pipelines across clouds and on-premises data centers.
 - Active Loop: A service designed to streamline and automate iterative processes, improving efficiency in data processing and model training.
 - MONAI-OHIF Framework: A specialized framework for medical imaging AI development, offering tools and resources for researchers and developers in healthcare.
 - Deployable DS Service: A new service type, Deployable DS, has been added to the catalog. This enables users to request and manage deployable DS

Marketplace Enhancements

- New Marketplace Categories:
 - ML Models category has been added to the Marketplace. Publishers can now sell their machine learning models to interested users through this dedicated category.
 - A new category named "Services" has been launched in the Marketplace. Publishers can now post and publish information about the services they offer, allowing users to discover and contact them as needed.
- A dedicated "In Process" tab has been added to the Marketplace dashboard:
 - Track every Marketplace item request you've made.
 - Chat instantly with publishers using our integrated conversation panel and send quotes and negotiate for the items you like.
 - Finalize your orders by accepting publisher agreements in a snap.
 - Dedicated status on each request to track its progress and current stage.
 - Search and filter for all your requests.
 - Close item requests with consumer/publisher anytime you want.
- The user interface now visibly differentiates between company and individual providers for service items within the Marketplace, offering clearer identification of the source of services.



- The ability to edit and delete service and ML Model listings has been implemented, providing publishers with greater control over their offerings.
- The "Published by" information on Marketplace item cards has been changed from displaying the publisher's name to showing the tenant's name. This makes items visible and attributable to the respective tenant.
- Users and publishers can now actively report false actions concerning data order tickets or any inappropriate comments/reviews, helping us maintain the integrity and quality of our Marketplace.

Publishing Center

- Publishers can now interact directly with users regarding data order tickets on a dedicated "Item Support" page within the Publishing Center:
 - This page allows publishers to view all data order tickets related to their published items.
 - Publishers can communicate with users through a conversation panel to address queries or provide support.
 - This centralized location streamlines the process of managing and responding to user requests.
- A new security report feature has been introduced for publishers, providing insights into the detailed security reports for items that fail to publish due to security check failures. This provides clarity on why an item was rejected and helps publishers address the issues.

Digital Assistant

- New connectors (tags) have been added to the research assistant, allowing for more refined and targeted searches within integrated resources.
- Discover Marketplace items effortlessly! Generative AI responses now include a direct link and description for available items, making your search and discovery process much faster and more intuitive.
- Opt-out users can now stop ongoing conversations and initiate new query prompts within the same session, offering more control over their interactions.
- An enabled tags section has been added in the create template functionality, allowing for better organization and searchability of templates.
- **Document Creation Assistant – Approval Workflow:** An approval process workflow (Team/Platform level) has been implemented for adding templates and managing templates within the Document Creation Assistant, ensuring controlled and standardized template usage.
- Library Enhancements:
 - The library now supports uploading various file types, including PPTs, documents, images, and videos, to the chat assistant for context, enriching the assistant's understanding and response capabilities.
 - Functionality for editing artifacts, renaming, managing reference links, and an approval process workflow (Team/Platform level) has been added for library content, providing comprehensive management tools.
- All platform areas previously impacted by license tier adjustments have now been fully updated. This ensures that Generative AI responses, Marketplace listings, Tenant management interfaces, and the Publishing Center consistently reflect the current available tiers, providing a unified and accurate experience.
- **Note:**



- Template creation and management functionalities are presently exclusive to "opt-in" users.

Admin Management and Controls

- **License Management for Super Admins:** A dedicated "License Management" tab has been introduced under the "My Tenant" section for super administrators. This new tab provides a centralized place to view, modify, and edit license tiers (Basic, Advanced, Enterprise) and their associated details, allowing admins to tailor licensing to their organizational needs.
